# **CST Bulletin (1976-80)**

# General socio-political background

The Labour government until 1979 faced problems of high inflation and many industrial disputes (eg newspaper unions, 'the winter of discontent'). Oil prices doubled. In 1976 \$3.9 million were borrowed from the International Monetary Fund. The Lib-Lab pact began and ended. Votes on devolution in Scotland and Wales failed to produce the required majorities. Margaret Thatcher (Conservative) became the first female British prime minister in 1979. Legislation included the Third Race Relations Act. The Commission for Racial Equality was established.

Away from politics, the Yorkie bar was introduced and there were a series of firsts: IVF baby born and produce bar code, first performance of 'Evita'. Concorde began regular passenger services, Britons owned more colour than black and white televisions, the Apple II was launched, Britain imported more cars than it manufactured. The Post-it note became available. Punk rock was replaced by the New Romantics. Elvis died. Fleetwood Mac released 'Rumours'. 'Star Wars' was also released. Skateboarding became popular. The Queen celebrated her silver jubilee. The Iranian Embassy siege took place. There was a hunger strike at the Maze prison and John Lennon was shot dead.

### **Bulletin**

The main themes which emerged during the late 1970s include CST accommodation, effectiveness of dysphasia therapy, the name of the profession, registration for speech therapists and the Clegg Report. The work behind the Warnock report and later its implications were reported.

Anne Christopherson (AC) and Renata Whurr continued as editors until 1 October 1978, when Rita Twiston Davies (RTD) became General Editor (No. 317) instead of AC. RTD resigned (her last issue as editor was No. 326, June 1979). AC became assistant editor of BJDC (No. 320). Margaret Gordon took over as General Editor, with an editorial team from the Victoria Infirmary Glasgow's Speech and Voice Pathology Department. The bibliography continued through 1976 (Nos 286, 290, 292, 294) but was stopped by vote at Council (No. 299) as it was felt that it was now easier to obtain references. At the same meeting it was agreed that *Bulletin* would not exceed 12 pages, that the costs of inserts, advertisements and notices would be raised and an annual budget was to be agreed (maintaining the maximum of 12 pages was reiterated in No. 331). Advertising rates were raised in 1979 (No.

324). Research notes were introduced (No. 336) - 79 ST research projects were listed by topic in this section (No. 337, with correction in No. 338). Cartoons appeared twice (Nos 335, 337).

### CST/HQ

Throughout 1976 Mrs Greenwood (Deputy Treasurer) was seeking accommodation for CST HQ, to replace the St John's Wood premises, which were shared with school meals organisers (Chairman's address 1977 AGM, enclosed with No. 315). The acquisition of new premises was announced in No. 294 (purchase of 6 Lechmere Road, London NW2, which was reportedly close to the previous office). CST had to raise £17000 (it had £10000 available). Mrs Greenwood requested that each member donate £6 to the College Building Appeal, which would clear the debt (No. 294). £2019.50 had been donated by No. 296, £3393 by No. 300. Council named the premises Harold Poster House (No. 300) after the man who provided a substantial donation towards the cost of the building, provided the office furniture and an opening reception. It was ready for occupancy by July 1977 (No. 302) and a method for booking its rooms was described (No. 311). National appeals for speech therapy were launched in July 1977 (No. 303). A list of donations received is given in No. 338. A President's evening is reported (No. 331).

The National Research Trust for Speech Therapy ran an introductory course in research method and analysis (No. 287). Its name was changed to National Speech Therapy Development Trust from April 1976 (No. 293). Notes of its meeting on 21 April 1977 were printed in No. 302. A new Memorandum and Articles of Association were adopted 16 July 1977 at an EGM (No. 305) and CST was registered as a charity by the Charity Commissioners. National Speech Therapy Development Trust monies were merged with those of CST (No. 307).

Leaflets and publications: information was sought from members on the CST communication chart in development (No. 286). It was completed (No. 296) and described in a paper by R Fawcus et al (No. 300). A questionnaire for its evaluation was printed in No. 310. A list of CST publications was given in Nos 327 and 334. A new technical aids pamphlet became available (No. 344).

CST conferences: a combined conference/refresher course was to be held in Brighton in 1976 to include Jansson Memorial Lecture by Lord Halsbury (No. 288). National conferences would now be held every three instead of four years and there would be no refresher courses in between (No. 289). The 1979 conference to be held in University of Warwick (Nos 298, 324). A notice for the national study day and AGM in 1978, including Jansson lecture was given in No. 313 and the same

for a national study day on mental handicap was enclosed with No. 314. Would members be interested in a study day in addition to the one held in association with the AGM (No. 317)? A conference for the International Year of the Child was planned (Language – whose concern?) (Nos 312, 324, programme in enclosure No. 328) but cancelled because of a shortage of bookings (No. 331). It was run later in a reduced form (No. 334), with its programme given in No. 335.

Subscriptions were increased from April 1976 (No. 285) and an increase was proposed for 1979 (No. 316). Subscriptions increased again from April 1980 (No. 335). The service from Press Cutting Agency had been 'far from satisfactory' and so was discontinued for a trial period (No. 292). Forwarding of pertinent cuttings by members was proving to be more effective (No. 299). Members were invited to write re: contributing documents, records or letters for the College archives (No. 318).

Jean Cooper was awarded FCST, for generous services to the profession (No. 308) and was also awarded a PhD (No. 319). Chronologically, Honours were presented to Peggy Carter and Patricia Languth (photo in No. 312). FCST was awarded to Pauline Griffiths and Honours to Muriel Morley (No. 329). Honours were awarded to Kathleen Morrison and Joan Pollitt, FCST to Frances Hatfield and FCST (Hon) to Prof Jack Joseph (No. 338). Muriel Morley was awarded an OBE in 1980 (No. 339). Gillian Barlow was expelled from CST (No. 342).

# The profession – themes and developments

Area appointments were listed (Nos 287, 289, 290, 291). DHSS adviser 'frequently asked questions' were answered by Betty Byers Brown (No. 323). A resolution re: annual registration for the purpose of practice was passed at the Council meeting in November 1978 – members views were sought (No. 324). Specific Interest Groups (SIGs) were beginning to be formed - SIG Geriatrics (Nos 312, 325, 338) and Scottish SIG Geriatrics (No. 333).

The question of changing the profession's name was raised again (letters in Nos 320, 322, 323, 324, 326, 328, 330, 331). Membership views were sought in No. 323. The top five names from this poll were to be used in a ballot (No. 327), which was kept open because of postal difficulties (No. 328). Enclosures with No. 330 included an 'important notice' to members re: the change of name, which gave the result of the June 1979 ballot. This resulted in a further ballot, with a choice of the most popular two names from the June ballot – 'speech pathologist' and 'speech therapist'. By 1033 to 515 votes, the name 'speech therapist' was retained (No. 334).

Clegg Committee: members were asked to contact CST if asked to submit written evidence (No. 330). The Clegg Commission report (Report of the standing commission on pay comparability) was discussed at Council 14 March 1980 (minutes enclosed with No. 336). The Chairman of Council wrote to the Secretary of State for Social Services on gaps and inadequacies (enclosure with No. 336) and therapists were involved in protest marches and demonstrations (enclosure with No. 336). Letters were printed on this topic (Nos 337, 338). The White Paper 'Patients First' also provoked a vociferous response from CST (No. 336) and was discussed at Council (enclosure with No. 338).

Lists of CST advisers appeared occasionally (Nos 285, 288, 321 (perforated pages for easy detachment), 332, 344). Lists of successful candidates in the CST qualifying examination and of university passes also appeared (Nos 305, 309, 317, 320, 321, 330, 333, 341). The Chairman's address to AGM had a regular slot (Nos 294, 318, 331, 343). The list of MSc in Human

Communication project titles for 1975 and 1976 were given in a letter (No. 295), in the text of Bulletin for 1977 and 1978 (No. 324) and in the research notes section for 1979 (No. 339).

Technology: adverts for the VSF Indicator (No. 298, enclosure No. 310) (visual speech unit), the Edinburgh Masker (No. 309) and electo-visual speech aid (ESVA) (more reliable model, now available with training programme and instructions) (No. 310). Article on SPLINK (No. 326), tape presentation available (No. 337). Article by Roger M Jefcoates in No. 339.

Notices of and programmes for Area meetings, meetings of more local discussion groups, NHCSS courses, various conferences and conference reports featured throughout the period as did adverts for books and publishers, with only occasional book reviews (eg Nos 289, 313). A regular book review feature began in No. 325 and continued in Nos 318, 332, 333, 336, 338, 339, 341 with very occasional themes, eg reading (No. 335), language pathology (No. 344) and some correspondence on a 'damning' review (Nos 341, 342).

#### **International issues**

The 17<sup>th</sup> IALP conference to be held in Copenhagen in 1977 (No. 285). A conference report by Sister Marie de Montfort was printed in No. 306 as was a report from an IALP meeting in East Germany (No. 322). The 18<sup>th</sup> IALP conference was to be held in Washington (No. 327) and was reported in No. 341. Lists of international conferences were printed occasionally, eg Nos 320, 333.
