### • Evidence about the College Honours system and Fellows generally

23 July 1945 letter from Eileen MacLeod to Winifred Cooke explains Fellowship of CST: 'There is a rule which enables the Council to confer a Fellowship in exceptional circumstances of outstanding merit, when the regular procedure of submitting a thesis is dispensed with. It is specified that the initiative lies with the Council; such Fellowships cannot be asked for by a member of the College. The seven years clause is not a qualifying but a <u>limiting</u> one – it prevents the Council deciding to confer a Fellowship on anybody, however meritorious, unless the member has been at least seven years qualified. The whole rule was made to provide for an occasional very exceptional case and is not an alternative means of becoming a Fellow, open to all who have at least seven years experience; <u>membership</u> of the B.S.S.T, now Fellowship of the College is not a question of seniority in the profession, it is a higher diploma awarded for special work and that work is the production of an original thesis based on personal research etc.'

Honorary Fellows 'consisted originally of distinguished members of the medical profession who had been associated with speech therapists in their work and continuously advised the 'Founding Committee' on how to set up the new professional body.' (Letter from Catherine Renfrew to Shirley Davis, 17 October 1991)

1959 Fellowships – 'Now that membership numbers over 1100 and the Council felt that it could award twelve Fellowships to senior members of the College who, because of the intensity of their work, could not find the time to submit a thesis, but were worthy of a Fellowship. The Fellowship was asked to nominate up to a limit of 12 members each and the names of the 12 members who gained the highest number of votes was submitted to Council for approval.' (Letter from Secretary of the Council to the new Fellows)

'We have been very parsimonious as a profession with the giving of this award [FCST]..... The value and status of Fellow lies only in the respect and regard in which those who hold the distinction are held. I would therefore deprecate a large sudden increase in their numbers such as the 'round dozen' that were awarded some 25 years ago which brought the award into disrepute for many years. However I would suggest that 4 or 5 might be a desirable number for election each year. I feel it unfortunate that recently three awards were given to members just when they were retiring from their professional work. This distinction would have been of much more value to them while they were working. Of the 15 elected in the last ten years, two-thirds have been given to those working mainly or entirely in the academic field, i.e. within a small proportion of our profession.' (Letter from Catherine Renfrew to M Edwards, Chairman of Council, 12 February 1988)

'The award of Fellowship was originally planned for members who produced a thesis of original research into speech disorders of a standard to be accepted by three external examiners as worthy of this status. ... As a result of the paucity of acceptable presentations, it was decided that members could submit their published books for acceptance, but even this inclusion did not markedly increase the number of Fellows. Later it was agreed that members who had made some outstanding contribution ... should be granted Fellowship. ... Later still when the MCST diploma was abolished, Fellowships were approved for all who had further qualified by that means.' (Letter from Catherine Renfrew to Shirley Davis, 1991) This letter includes corrections to the list of Presidents, Chairs, Fellows and Honours in the 1990 Annual Report 1990.

The College Honours Committee was established in 1977, previously Fellowships were elected directly by Council. The Honours Committee received nominations and decided if they were to be recommended to Council. The first Honours went to Pat Languth and Margaret (Peggy) Carter in 1978. Their object was 'those members who had given special service over a long period to the College – not to the profession only – be recognised.' (Letter from Catherine Renfrew to Chairman of Council, 1982)

The 12 people who had qualified MCST by exam had that qualification re-categorised as FCST in July 1981. They were Mrs BJ Bennett, Mrs B Byers Brown, Mrs A Christopherson, Miss JL Cook, Mrs R Eaton, Mrs CR Jones, Mrs E Mitchell, Mrs PA Pollard, Mrs J Smith, Mrs AM Stoneman, Mrs NM Voyce, Mrs R Whurr. MCST thereafter indicated subscribed membership of College. Council meeting 26 June 1981 agreed the following: those who had passed the CST qualifying exam may use DipCST or LCST or both (so after the name people could use DipCST, MCST; LCST, MCST or DipCST, LCST, MCST). Graduates would add MCST after their degree qualification.

The award of Honours was subsumed into Fellowship in 2008.

the Minute of 1945 restricting Hon. Fellows to 5% - it should not be more than 1% with our present numbers. In 1945 we had 200 members and had just made six Hon. Fellows and deemed it wise to limit the number...' (letter from Joan van Thal to Miss Collis (CST secretary), Nov 16<sup>th</sup> 1966)
